## **SOBEL TROPHY**



This trophy is a bronze statuette, 24 inches high, of a Toledo, OH, Police Officer in the act of drawing his pistol. It is mounted upon an eight inch base. It was placed in competition in 1928 by Mr. Louis Sobel of Toledo, who was First Lieutenant of Infantry in the 91st Division during World War I.

## Match Conditions:

- 1928 Open to teams (police) of five shooters. In all other years listed, it was open to teams of four firing members. Course of fire:
  a) Five shots at running man target, three shots as the target runs in one direction, two shots in the opposite. Distance, 50 yards, b) Five single shots at field targets as exposed, 20 to 50 yards at various angles. c) Arm any center fire pistol or revolver.
- 1941 Course of fire changed to:
  - a) Five shots right hand at "E" silhouette target
  - at unknown distance from 20 to 75 yards. Five shots to be fired in 10 seconds. b) Same course with left hand.
- 1979 Converted and given to Individual Winner of NRA National Police Championships. Course of fire: 150-shot National Individual Police Revolver Course.
- 1989 Revolver changed to Pistol.
- 1999 Individual Championship is now an aggregate of both the Revolver and Semi-Automatic Pistol 1500's.
- 2007 Removed from competition
